Noted the following resolution of Tender Evaluation Committee meeting held on 01.02.2019:

Noted that the Technical Bid was opened on 31.01.2019 for the e-tender No. NNDC/e-Tender/NIT/2018/4th Call dated 08.01.2019, Tender ID: 2019_DHE_205918_1 for "Construction of eight number new RCC Columns along with Ground Improvement including Micropiling & Grouting below column footings for supporting the distressed 4 storied building of Netaji Nagar Day College, Regent Estate, Kolkata-700 092".

Resolved that the Technical Bid from single bidder after 4^{th} Call i.e. S. Ghosh & Associates Pvt. Ltd. be accepted on the following ground:

From technical point of view, the single bidder after 4th Call, namely S. Ghosh & Associates Pvt. Ltd. is found eligible as per eligibility criteria specified in the tender for having completed within last 5 years as a prime agency two similar work involving micropiling and grouting for soil improvement. This is as per documents uploaded by S. Ghosh & Associates Pvt. Ltd. as credential of execution of similar type of work.

Noted also that the financial bid placed by M/S, S. Ghosh and Associates Pvt. Ltd, is Rs.45,75,489/-(Rupees Forty Five Lakh Seventy Five Thousand Four Hundred and Eighty Nine only) which is 1.89% higher than the amount put to tender, i.e. Rs. 44,90,617/- (Rupees Forty Four Lakh Ninety Thousand Six Hundred and Seventeen only).
