Best Practices (A)

> Title of the Practice:

Enhanced access to e-recourses for faculty

➤ Goal:

To enrich and update knowledge base of faculty members.

> The Context:

The institution has the vision and mission to be one of the best colleges in the city. Wider access to knowledge regarding latest developments in each discipline thus becomes a primary condition for the faculty.

> The Practice:

Online access to books and journals available through subscription to N-List programme of INFLIBNET. More than 1300 journals and 14000 e- books are available therein. Personal password given to individual teachers under N List programme.

Evidence of Success:

The faculty can access the e-resources under N-List both in-campus and off-campus through individual password. This facility is used extensively by the faculty for teaching as well research.

> Problems encountered and Resource Required:

Space constraint limits the number of computers available in the library for access to e-resources. Financial assistance if made available by the UGC and / or state govt. can be utilised for new space saving furniture in the UGC Resource Network Centre in the Library to accommodate more uses at a time. Inter-library networking can also be established.

Best Practices (B)

> Title of the Practice:

Further growth of sports and NSS activities of students.

➤ Goal:

To groom students' potentiality for extra-curricular activities and also to nurture the sense of social responsibility.

> The Context:

The founder members of the institution had the vision and mission to involve the students in all co-curricular and extra-curricular activities which will improve their health and mind and also in welfare activities having 'community orientation'.

> The Practice:

With their natural inclination a large number of students including girl students participate in different sports and games as well as in extension activities through NSS.

Evidence of Success:

141 students participated in sports and games. Several prizes are won in inter-college sporting events. A wide range of extension activities are undertaken by NSS units of the College.

> Problems encountered & Resource Required:

Long schedule of University examination hinders the development of student's potential in this sphere. The playground for sports and games is shared by two other Colleges. To maintain livelihood is another major problem for many sports activists which compels them to leave their sports career midway for taking up jobs.

More funds are required to provide necessary equipments and other facilities for sports and games and for extension activity.
